The Community Futures Program (CFP) is funded by the Government of Canada. Formally established in 1985, the CFP was implemented to support business development in rural and remote communities. Three decades later, CFPs largest, most well-established national community economic development movement.

# **Financial reports**

In the 2023-2024 fiscal year, the Prescott and Russell Development Corporation (PRDC) approved loans and lines of credit totaling more than \$1,413,165 in the Prescott and Russell and Southern Ontario regions. Of those approved funds, \$1,163,165 were disbursed from various funding programs such as the Investment Fund (IF) loan and line of credit, the Regional Relief and Recovery Fund (RRRF) and the Economic Development Initiative of Southern Ontario (EDISO) for various start-up, maintain and expansion entrepreneurial projects.



At the end of the 2023-2024 fiscal year, the PRDC's total loan portfolio consists of 109 active loans throughout Prescott and Russell and the Southern Ontario regions. We proudly serve all under-represented groups such as members of official language minority communities (22), women (11), young entrepreneurs (5), social businesses (1) and visible minorities (2).

The Economic Development Initiative of Southern Ontario (EDISO) aims to address the economic challenges of the Southern Ontario Francophone business community and strengthen regional successes to foster sustainable growth in minority official language communities. It also seeks to promote the development

of new expertise in the areas of innovation, economic diversification, and partnerships, as well as to provide increased support to small and medium-sized Francophone businesses.

Under the authority of the Board of Directors, the objective of the Investment, Young Entrepreneur, Express and Economic Development Initiative of Southern Ontario (EDISO) loans is to create and maintain full-time and part-time employment opportunities in the regions by providing new and existing businesses with a source of financing with a flexible payment structure.

#### **Investment Fund Ioan**

The Investment Fund loan offers term loans up to a maximum of \$300,000 to new and existing businesses in the Prescott and Russell region. This financing source offers a flexible structure with adaptable repayment terms, and includes project evaluation and assistance in securing realistic funding.

## Young Entrepreneur loan

The Young Entrepreneur Loan aims to counter the migration of young people to large urban centers and is designed to support young entrepreneurs aged 18 to 39 in the Prescott and Russell region with financing ranging from \$5,000 to \$30,000. This program promotes youth leadership and values their social, cultural, and economic engagement in our communities.

## **Express loan**

The Express Loan is designed to support the continuity of operations for businesses in the Prescott and Russell region. Financing of up to a maximum of \$15,000 is available for expenses such as leasehold improvements, inventory increase, working capital support, equipment upgrades, and marketing, to name a few. A decision will be communicated within 72 hours (business days) if the application is complete


### **EDISO** loan

The Economic Development Initiative of Southern Ontario (EDISO) offers funding up to a maximum of \$30,000 for francophone and bilingual businesses in the Southern Ontario urban and rural regions. An additional \$15,000 can be obtained through our partner the Fondation franco-ontarienne, for a total of \$45,000.

## Line of credit

The maximum financial assistance of **\$150,000** through a line of credit, provided through the Investment Fund program, is offered to incorporated SMEs only. The borrower can borrow money from his/her line of credit in whole or in part, according to his/her needs and with proof of justified invoices. The funds can be used for a variety of reasons including business expansion, leasehold improvements, cash flow management, cash flow for contract purposes, bill payment and/or unexpected expenses.

#### CHECK-IN MARKET

is a company located in Rockland, ON, specializing in the sale of Afro-Caribbean

products. They offer a wide selection of exotic flavors from Africa and the Caribbean. Funding from the EDISO program has enabled the business to acquire refrigeration equipment, and inventory, and make renovations while creating one job and maintaining one full-time position.



The TÉLÉVISION COMMUNAUTAIRE DE LA CITÉ CLARENCE-ROCKLAND INC. (TVC22) is a nonprofit organization that produces and broadcasts local programs. Established in 1990, they promote bilingual free-access television, where everyone can collaborate or submit community projects that are overlooked by mainstream media, and connect with others. This project will help maintain 9 jobs.

The Express loan best suited this organization's needs as the clients received their approval within 72 hours after submitting their request.

#### CREATIVE CELEBRATIONS

is a small business based in Rockland ON that offers a unique way to celebrate all occasions by bringing joy to families and friends through the creation of lasting memories.



The Investment Fund has created one full-time job and maintained another full-time job by assisting with equipment acquisition, marketing, and inventory.





The **MARVELLA GROUP**, from Hawkesbury ON, specializes in commercial painting, residential painting, plastering, and wallpaper installation.



Since this project was in its start-up phase, the PRDC helped with funding from 2 different programs, the Investment fund and Line of credit. These funds, along with the business' investment were for cash flow and equipment purchasing to fulfill its contracts.

Both of those funding options offered the client flexible terms and reimbursement which helped maintain 5 full-time positions as well as create 5 new positions.

**Light bulb:** the light bulb represents innovation, creativity, ideas and vision. It's also representative of our mandate, mission and our values.


